New Yorkers know that for every electric, vibrant moment, New York City can also be a tough place to live. In this city where nearly 8 million people have something to offer, not all New Yorkers are equally able to afford an attorney to guide them in accessing justice for their civil legal challenges. That's why access to justice through pro bono has been VOLS' innovative, foundational principle for nearly four decades. As VOLS looks forward to celebrating our 40th anniversary this spring, there is much to share about the remarkable growth of our organization and the availability of pro bono legal services throughout all five boroughs.

In our last fiscal year, more than 6,200 New Yorkers benefited from VOLS' high-quality, free civil legal service projects, and many thousands more attended community legal education workshops and trainings, and accessed our know-your-rights guides and materials. We handled more matters for clients than in the history of our organization and worked with the private bar to support over \$17.8 million in free legal services for immigrant youth, incarcerated mothers, older adults, veterans, small business owners, individuals entitled to public benefits, children and their families.

This impact report features some -- though nowhere near all -- of VOLS' work over the past fiscal year. Thank you to our clients for trusting VOLS with their dreams, to our pro bono and community partners for their time and collaboration, and to our supporters for providing the means that move the work forward.

Our Model

VOLS' model is to first identify legal issues facing low-income New Yorkers through our relationships with community-based organizations and then to organize programming, staffing, and pro bono support that address these real needs. Our model provides us with extensive opportunity for feedback and guidance from the community and lets our team focus on the legal challenges that need to be addressed.

Pro Bono Partners

VOLS works with 80 law firms and companies. We connect and support a network of nearly 1,800 active pro bono volunteer attorneys to provide legal services.



VOLS' staff provide free direct civil legal services; recruit, train & mentor pro bono volunteers; provide community education, training & know-your-rights materials in multiple languages.

Community-Based Organizations

VOLS works with 150 schools, hospitals, older adult centers, and other organizations to identify and support clients. We collaborate on community legal education, identifying emerging legal trends impacting communities and identify community members in need of support.



Each VOLS Legal Team Member

Screens clients and performs intakes; manages a caseload and directly provides clients with advice and counsel. Trains and supports pro bono, significantly multiplying impact and numbers of clients served; creates guides and other resources and provides continuing legal education. Presents community legal education, know-yourrights and other trainings; deepens relationships within the communities served.

VOLS Senior Law Project

Older adults deserve to age with dignity and have their wishes met by their chosen caregivers. VOLS Senior Law Project (SLP) assists older adults with limited income in securing legal documents, so they can make key decisions for incapacitation, end-of-life, and posthumous care. Our project takes a population-based approach, with specific initiatives for veteran, women, LGBTQ+, and Latine/Spanish-speaking New Yorkers that provide culturally competent legal services, respond to language access needs, and meet older adults where they live and congregate. In one thriving new community partnership, our team hosted legal clinics with Visions, the older adult center in Selis Manor, Manhattan, in order to serve older adults who are blind or have vision impairments. Our program will continue to ensure that clients with differing abilities are able to access VOLS SLP's life-planning services. This year the SLP provided legal services to more older adults- and drafted and executed more life planning documents- than ever before. We also are responsive to caregivers' needs. When our clients name an agent in a Health Care Proxy or Power of Attorney, their agent(s) often have questions about what this means and their responsibilities. VOLS SLP created two new guides for older adults and their caregivers to help demystify what it means to be an agent.



VOLS Benefits Law Project

After careful planning, in June 2023 the VOLS Unemployed Workers Project (UWP) became the VOLS Benefits Law Project (BLP). During the last fiscal year, VOLS UWP had provided unemployed workers with assistance on federal and state unemployment insurance, advising on eligibility, applications, claims, waivers and requests for hearings. We saw an increase in positive determinations for clients receiving assistance from our corps of pro bono attorneys and continued to work with coalitions to advocate for reforms at the New York State Department of Labor to improve the waiver system, improve accessibility, and increase transparency. Building on the success of UWP, on June 1, we officially expanded and launched the VOLS Benefits Law Project (BLP), empowering New Yorkers to access a wider range of public benefits, including the NYC Rent Freeze Program – Senior Citizen Rent Increase Exemption (SCRIE)/Disability Rent Increase Exemption (DRIE) – and Social Security Disability Insurance (SSDI)/Supplemental Security Income (SSI) benefits. Our launch event at Hamilton-Madison House served 87 New Yorkers, and we look forward to assisting many more.

VOLS Incarcerated Mothers Law Project

A unique program in New York State, the VOLS Incarcerated Mothers Law Project (IMLP) provides high-quality, free family law services to mothers* in and recently released from prison and jail who are seeking information about their family law rights. We hear from mothers who have not seen or been given copies of their custody orders and do not know what their rights are or how to enforce them; who are not being given visitation or telephone access to their children despite a custody order that requires it; who are unable to get access to make a telephone call to their child from prison; who wish to contest an adoption or foster care placement; who need to arrange care for their children; whose letters are not being delivered to their children; whose children have been moved out of state against a custody order. This fiscal year, VOLS IMLP gained in-person access to correctional facilities following COVID-19 entry restrictions, including to Taconic Correctional Facility and to Bedford Hills Correctional Facility, where mothers have been waiting to speak with a family law attorney for many years.

VOLS Immigration Project

VOLS Immigration Project (IP) serves one of the most resilient populations in the city: immigrant youth. In providing free, high-quality immigration legal services, we help ensure access – and continued access – to education and economic opportunity for the young people we serve. Whether it was addressing the needs of DACA clients to maintain post-secondary educational and employment opportunities or helping address the needs of young new arrivals, our model focused on increasing accessibility to immigration legal services by reaching youth in their communities. That's why this year, when International High School at Laguardia Community College needed help educating staff and new arrival families on options for relief, VOLS was their first call. VOLS provided an Immigration 101 training that was Zoomed into every classroom for the school. School staff said the impact was transformational – empowering students to approach VOLS for legal assistance and providing hope and assistance for the future.

VOLS Microenterprise Project

Our VOLS Microenterprise Project (MEP) clients never fail to impress us with their ingenuity and drive. This year, VOLS MEP provided free legal advice and services to new and existing low- and moderate-income small business owners in all five boroughs. We significantly increased access to legal services for an important group of New York City's microentrepreneurs: New York City Housing Authority (NYCHA) small business owner residents. We formed a new relationship with the Fedcap Jobs-Plus program, which offers place-based employment services program for working-age NYCHA residents, and participated in Progress Playbook's NYC Safe Pitch Competition, which identifies and incubates NYCHA-resident entrepreneurs to provide participants with legal clinics about entity formation, contracts, and intellectual property basics. We also worked closely with pro bono subject matter experts to create new presentations for clients on cybersecurity and privacy as well as entity tax advice, responding to how many people have needed – but could not afford to access to – this information that is critical to running a modern business.



VOLS Children's Project

VOLS knows that accessibility to legal services means showing up in the spaces where our clients most need us. That's why the VOLS Children's Project (CP) is a unique program that matches and supports pro bono partner law firms with hospitals and schools in order to provide children and families with free legal services in hospital and school-based settings. VOLS housing and immigration specialists and legal team provides as-needed legal services, in one example supporting a lawsuit on behalf a child at PS 188 The Island School in downtown Manhattan whose apartment was overrun with mold and no action was being taken. Through our advocacy, VOLS legal team and our pro bono partners secured an agreement to make the repairs and a six month rent abatement for the family.

VOLS Clients

NM, Client, VOLS Senior Law Project Senior Women's Empowerment Initiative

After NM was diagnosed with early dementia, her caseworker reached out to VOLS to help get her life planning documents in order. NM lived with her long-term partner who she had wanted to name as power of attorney and health care proxy. After receiving the referral, VOLS immediately got into contact with the client and her partner, who also wanted to prepare her life planning documents. VOLS worked with both women and prepared their Wills, Powers of Attorney, Health Care Proxies, Living Will, and Control of Remains forms. For this loving, legally blind couple, VOLS' work was vital to ensuring that their wishes were carried out. As an LGBTQ+ couple who never married or registered as domestic partners, without legal authority, they would face barriers when making health care decisions on each other's behalf and did not have spousal inheritance rights. It was essential to get these documents prepared and executed so the clients' wishes could be carried out while they both still had the capacity to do so. VOLS is proud to offer culturally competent services that allow older adults to take control of their future and live with dignity in the places they call home.

Nia Hooper-Mason Client, VOLS Microenterprise Project

Nia Hooper-Mason is passionate about how her work supports the community. She is the founder and owner of the online store, Love Joy Originals (lovejoyoriginals.com), that sells sustainable childrenswear with positive affirmations for mamas to inspire their children to be great. VOLS worked with Nia to update her corporate governance documents, create website policies and advised her about best practices in cybersecurity. This year, VOLS partnered with pro bono to launch cybersecurity and privacy trainings that support business owners like Nia to navigate law and technology. As a result, Nia can confidently move forward with her business, knowing she has legal protections in place.

GV, Client, VOLS Immigration Project

At two years old GV - now 19 - came to the United States with her mother. Her immigration journey reflects so much of how VOLS works with youth to access safety, education, and employment opportunities and support them in fulfilling their goals and how we maintain ongoing support for our clients to address recurring or new immigration law issues. GV has been represented by VOLS since 2020, first in Family Court, where she was granted a Special Immigration Juvenile Status (SIJS) predicate order that allowed her to file an application for SIJS, along with a green card application. SIJS is granted for young immigrants under the age of 21 who have been abused, neglected, or abandoned by one or both parents, a situation GV unfortunately experienced. VOLS then worked with GV so that her green card application was approved, making her a lawful permanent resident of the United States and providing her with the ability to attend Lehman College and apply for scholarships and financial aid that were previously not available to her. GV is currently attending Lehman College, furthering her education and planning for her future. In five years, she will be able to naturalize to become a U.S. citizen. We are so proud to support her on this journey!




Staff Demographic Survey: FY23


