## More than a Case: The VOLS Model

The VOLS Model begins by identifying pressing civil legal issues affecting New Yorkers. We structure our programs, staff, and pro bono resources around these needs. Our approach is continually refined through feedback and guidance from the communities we serve, ensuring our efforts effectively address our clients' civil legal challenges.

We are a Pro Bono First Organization – every VOLS' project and initiative is designed to maximize support for our clients by incorporating pro bono volunteers from private law firms and companies. **That's how one VOLS' attorney becomes many**. We can take more cases, serve more New Yorkers, and tap into more resources for our clients than we could through our nonprofit staff alone.

#### **Pro Bono First**

VOLS works with 83 law firms and companies. We connect and support an active network of 1,800 pro bono volunteers who take cases, make community legal education presentations, and help develop up-to-date materials.







#### **Our Team**



VOLS' team provides direct civil legal services and recruits, trains, & mentors pro bono volunteers. The team provides accessible community legal education and training.

## **Community Partnerships**

VOLS works with schools, hospitals, older-adult centers, community-based organizations, and New York City and State government officials to support our clients. We collaborate on community legal education, identifying emerging legal trends and identify community members in need of support.

## More than a Case: A New Yorker

#### JAVP, Client, VOLS Immigration Project

When JAVP was just 11 years old, he bravely testified before a family court judge about the abandonment and neglect he faced from his father while his mother sought full custody. Although he was eligible for a Special Findings Order that would enable him to apply for Special Immigrant Juvenile Status (SIJS), JAVP didn't have the legal support needed to navigate the process. Fast forward nine years, and JAVP returned to court with VOLS by his side. He shared his experiences regarding his father's absence and requested that the court appoint his mother as his guardian. With our assistance, he successfully obtained the necessary court orders to apply for SIJS. Now an aspiring biochemist focused on a research career, JAVP can concentrate on his education and future goals. We are proud to support him as he moves forward on this important path.

#### Ezekiel Woods Client, VOLS Microenterprise Project

VOLS MEP client Ezekiel Woods is the owner and chef of Brighteye and Shilling, a catering business specializing in authentic Carribean cuisine and custom cakes for weddings, special events and celebrations. A passionate cook from a young age, Ezekiel gained professional experience as a pastry chef before starting his dream business in Brooklyn. VOLS MEP provided critical support in forming the business, so Ezekiel could focus on building his incredible menu: Curry Goat, Beef Oxtail, and Fish Cakes are only some of what he has to offer.



#### **CB, Client, VOLS Senior Law Project**

CB is an older veteran referred to VOLS by SAGE, a community-based organization supporting LGBTQIA+ older adults in New York City and around the country. CB wanted to prepare his end-of-life planning documents to ensure that his daughter could assist him with his banking and government benefits. VOLS promptly reached out to CB to begin the process of executing his Will, Power of Attorney, Health Care Proxy, Living Will, and Control of Remains form. Our team provided support at every step, staying in close contact and following up diligently, especially when CB needed to attend to family matters during the process. Once his initial documents were complete, CB contacted VOLS again. This time he wanted to re-execute his Power of Attorney to empower his daughter to act on his behalf regarding Medicaid. We arranged an office visit as soon as possible to facilitate this update. VOLS' assistance was crucial in ensuring that CB's wishes would be honored by his chosen caregiver, alleviating some of the uncertainties he faced about his future.



I am a Legally Blind Senior, which meant [VOLS' team] read out loud to me and explained the Will, POA, Living Will, Health Care Proxy, Agent to Control Disposition of Remains Form, and other documents. They never faltered or lost steam. In fact, they seemed very happy to do it. I can't begin to thank them enough... And of course, not to forget all of the work put in at the beginning. Organizing all of this, from emails to phone interviews. Very efficient and professional.

# **VOLS Senior Law Project**

VOLS SLP empowers older adults to ensure their wishes are clear in the event of their incapacity or death, identify their chosen decision-makers for medical and financial affairs, identify what those decisions look like, and plan posthumous care for themselves and their property. Our program has targeted support for communities of veteran, women, LGBTQIA+, Latine/Spanish-speaking, and Chinese American older New Yorkers.

An older New Yorker, AD took great pride in his job in the post office, eventually retiring with a pension. AD had been born deaf and mute. As he aged, AD experienced declining vision, eventually becoming blind. At that point he felt it was too difficult for him to manage administrative tasks related to his fixed income and reached out to VOLS SLP for help. Our team was ready! VOLS' pro bono team secured a hand-sign interpreter and promptly helped AD execute a Power of Attorney and a Control of Remains form. Now, his adult children can help him maintain economic stability by managing his pension and other financial administrative tasks.



Having your documents in place provides benefits for older New Yorkers. It promotes control over their final years, and increased quality of life, supporting housing, medical, property, and basic needs.

# **VOLS Benefits Law Project**



Having an attorney's support for public benefits issues is often the difference between acceptances and denials.

VOLS BLP helps New Yorkers with limited resources more equitably access essential public benefits: Unemployment Insurance (UI), Senior Citizen Rent Increase Exemption (SCRIE)/ Disability Rent Increase Exemption (DRIE), Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI). Our team assesses clients for eligibility, helps clients apply for benefits as well as renew and recertify existing benefits, and appeals denials.

Access to technology, language barriers, complexity, and social stigma can deter individuals from accessing public benefits. We help address these issues and work with community-based organizations to share information about these critical programs.





TG received UI benefits after leaving her job at a major healthcare network in New York. She had just had a newborn and was unable to afford childcare with the long hours and 10-hour shifts. A year later, the Department of Labor told her she had been "overpaid" because she was looking for part-time work instead of full-time work, which was a requirement to receive these benefits. VOLS stepped in to help TG challenge this decision. Our legal team explained that TG was actually looking for full-time work, but had thought looking for 35-40 hours a week was considered part-time as her previous job required over 60 hours a week. With VOLS' support, TG didn't have to pay back the \$11,000. This new mother was able to move forward without added financial strain.

VOLS BLP community partners are vital collaborators in our work, hosting community legal education presentations, workshops, and clinics, and providing community members with guidance on how to access our services.

Last year we worked with Breaking Ground, Chhaya CDC, DSI International, Garden of Hope, Hamilton-Madison House, Heights & Hills, Jahajee Sisters, La Colmena, Nido de Esperanza, Mixteca, Sakhi, Voces Latinas, University Settlement, St. Nick's Alliance,

Entertainment Community Fund, Hudson Guild, NYC Department of Finance (DOF), NYC Housing Preservation and Development (HPD), and the New York Public Library.



# **VOLS Immigration Project**

VOLS IP supports immigrant youth and their families seeking safety and opportunity in the United States. We provide comprehensive eligibility screenings, pro se application assistance, brief legal advice, and/or full representation on a range of immigration legal matters, including humanitarian relief (asylum, Special Immigrant Juvenile Status (SIJS), Temporary Protected Status (TPS), U/T nonimmigrant status, VAWA relief, DACA renewals), work authorization, and removal defense.

This year saw an increase in new arrivals to New York City. Our dynamic model is designed to evolve alongside the changing needs of our community, ensuring that we're always ready to meet them head-on. We partnered with Trinity Wall Street to provide screening clinics at Trinity Commons for newly arrived families residing at a local shelter.

The young people who come to us often are navigating trauma, cultural and language barriers, fears of deportation, family and job responsibilities, lack of housing, and questions about eligibility. Through our direct legal services, community education presentations, training sessions, and clinics, we provide crucial assistance in addressing both emerging and recurring immigration law issues.

VOLS' client KT is a teenager who qualifies for SIJS, a protection designed for immigrant youth who have faced abuse, abandonment, or neglect by a parent, creating a pathway to lawful permanent residency. VOLS assisted KT in securing the necessary orders from Family Court, allowing her to file her application for SIJS. Once granted, SIJS will open doors for KT, making her eligible for a work permit and a social security number. This year KT is in the 11th grade and considering her plans after high school graduation. With a social security number, she can apply for college financial aid—an option that was previously out of reach. We wish KT a fantastic 11th grade year!

# VOLS Incarcerated Mothers Law Project



We work closely with nonprofit organizations Hour Children and Osborne Association to reach and support our clients and their families.

VOLS IMLP grew significantly this year to meet the demand for our services in a post-pandemic world. Our team provided high-quality, free family law services to incarcerated mothers and parents who cannot otherwise access information on their rights, including to visitation, contact, custody, foster care/adoption placements, and childcare arrangements. With our incredible pro bono partners, the team traveled monthly to Bedford Hills Correctional Facility or Taconic Correctional Facility to meet with these mothers and provided telephonic advice to mothers at Albion Correctional Facility and Rikers Island's Rose M. Singer Center. With the partnership of pro bono at Fried Frank, VOLS IMLP expanded services to assist incarcerated mothers with their uncontested divorces – within a few months there was already a waiting list.

VOLS is the only program in New York State that provides a full range of family law support at these facilities. Our work is vital to helping combat some of the harmful impacts of incarceration on mothers, children, and families.

BW first met with the VOLS Incarcerated Mothers Law Project because she was fearful and concerned for her child. She didn't know where her child was living, if he was enrolled in school, or if he and his quardian had permanent and stable housing. She could not stop thinking about him and wondering if he was okay. VOLS reviewed BW's case with her and joined forces with community partner Hour Children. Over the next few weeks, our team was able to locate her son and confirm that he was enrolled in and attending school. BW believed there was an Order of Protection in place preventing contact. Our team got to work by first requesting and obtaining all relevant family court orders. We discovered that, in fact, there was no Order of Protection, and that an Order of Visitation had been issued allowing BW regular telephonic contact with her child along with school and medical updates by the father. After unsuccessful attempts at contacting the father to resolve the issue, our team filed an enforcement petition and a modification petition in family court. With the court's intervention, the father began complying with the visitation order.

# **VOLS Microenterprise Project**

VOLS MEP provides free transactional legal services to new and existing small business owners that have limited resources and come from underserved communities. Despite great need, there is a lack of affordable legal resources for small businesses in New York City. In fact, a lawyer is one of the most expensive aspects of business formation and continuation. For many of our clients, the costs associated with this process are unattainable. Through our work, clients no longer need to worry about legal fees and are able to get access to the services that help them launch their businesses and avoid crisis. Our team provides free legal support on transactional matters including advice on legal entity selection and formation, creating and maintaining governance documents, drafting and evaluating contracts, reviewing compliance with employment laws, and protecting intellectual property. VOLS MEP also prioritizes community outreach and education for small business owners. Throughout the year, VOLS MEP also holds several community education workshops and clinics and provides up-to-date information on emergent issues.







This past fiscal year we launched a partnership with the NYC Department of Small Business Services' Black Entrepreneurs NYC initiative to make legal services more accessible.

**VOLS MEP partners with over 25 community-based** organizations to increase access to free legal services and education. Our partners currently include: Bedford Stuyvesant Restoration Corporation - Brooklyn, Black Chamber of Commerce of New York City, BE NYC, Brooklyn Chamber of Commerce, Brooklyn Small Business Development Center, Evergreen, Fedcap, Harlem Business Alliance, Local Development Corporation of East New York, Bronx Small Business Development Center, Columbia University – Harlem Small Business Development Center, Manhattan Small Business Development Center, NYC Business Solutions - Upper Manhattan, NYC Business Solutions Washington Heights, Chhaya Community Development Center, NYC Business Solutions – Queens, Queens-LaGuardia Small Business Development Center, NYC Business Solutions - Staten Island, Business Outreach Center Network, Progress Playbook, Small Business Legal Relief Alliance, Hot Bread Kitchen, Eterra Kitchen, and CAMBA.

JL was one of over 140 NYC small business owners that VOLS connected with at the NYC Small Business Services Expo. A former medical assistant, JL suffered from an accident that put her out of work for almost two years. During this time, she found her passion: baking. Once able to work again, JL decide to build the business of her dreams. She acquired her food handler's license and came to VOLS interested in forming a legal entity. VOLS and the pro bono team have supported JL in forming her company – filing the necessary documents, drafting the operating agreement, and taking other transactional steps she needs to take to protect and get her business off on the right foot.

# **VOLS Children's Project**

Through VOLS Children's Project, pro bono attorneys work closely with VOLS' team to help families address legal problems that may impact a child's health, education, and security. These often include housing, education or immigration law matters – and our volunteers work with VOLS' team members to tackle difficult issues for families going through some of their toughest times with their children.

At one downtown school, VOLS supports our pro bono partners at Kramer Levin Naftalis & Frankel LLP in providing individual legal services to students and their families through regularly scheduled onsite legal clinics. MG and her young children fled their home in South America to seek asylum in the United States. In her home country, MG had experienced physical and mental abuse from her partner and the family also faced discrimination in accessing healthcare and education based on a medical condition. With VOLS' support, the pro bono team worked diligently to guide this family through a removal hearing and asylum application. We are thrilled to share that this month the New York City Immigration Court granted humanitarian asylum to this resilient family. The family is now living safely in New York City.



Dean's List honoree Brian Budnick, Associate at Cravath Swaine & Moore, exemplifies the values and work of this project. Over the past four years, Brian has been the main advocate for a critically ill and severely disabled child receiving life-saving medical treatment at New York-Presbyterian Morgan Stanley Children's Hospital. Embracing the Project's holistic approach, Brian worked tirelessly to address the family's immigration legal needs and secure critical housing. We are proud to have Brian's support of this important program for children and families.




